



**DATES & TIMES:** November 14 & 15, 2015 Saturday & Sunday 11:00 - 5:00 pm

**LOCATION:** Located 30 miles northwest of Atlanta. Downtown Woodstock features speciality shops, restaurants and pedestrian friendly brick-paved walkways. A walk through Downtown Woodstock brings back the beauty of days gone by with the convenience of today and the allure of the future. Woodstock Art and Wine Festival is located in the Park at City Center in the center of town.

**ART:** All pieces must be hand crafted by the artist and categorized as a “fine art or craft”. Resale or wholesale items (buy/sell) *are not* permitted and will result in immediate dismissal without refund. No manufactured, imported items or raw materials will be allowed. Accepted categories include jewelry, pottery, glass, painting, photography, textile, wood and other fine art and craft forms. Artists may only show and sell work from the category in which they have been accepted.

**ARTIST:** The artist must arrive on time and stay for the duration of the festival. Artists may not open their booth late or close early. No agents, dealers, or representative may attend in place of the artist. Only one artist may display in a booth unless the work produced is a collaboration of two artists.

**BOOTH:** Booth size is either 10 X 10 or 10 X 20. Artists must furnish their own tent (white canopy top is preferred), display tables, skirting, & chairs. All displays must be designed, constructed, and operated in good taste. All displays, sales and promotional activities must be confined to artist’s assigned space. Tents must be weighted, staking is prohibited-\$50 fine (on the spot) will be assessed.

**PARKING:** Free artist parking (trailers, motor homes and vehicles) is available close the festival site. Artists must park in the designated parking area with the exception of set up and tear down.

**SET UP:** Either Friday, November 13th from noon - 5:00pm or Saturday, November 14<sup>th</sup> from 7:00 – 10:00am. All cars must be removed from the festival area 30 minutes before the festival begins and returned to the artists parking area. Vehicles are not permitted in the festival area during the festival hours.

**TEAR DOWN:** May begin at 5:00 pm on Sunday, November 15th, however; vehicles are not permitted in the festival area until you are prepared to load out.

**SECURITY:** Management provides nominal after hour security for the festival with the understanding that Premier Events, LLC, the City of Woodstock or Creative Event Specialists will not assume any liability for lost, stolen or damaged items.

**PHOTOS-NO SLIDES:** Must be actual photos of the art. They must also be clear and current photos. Submit a total of 5 photos (4X6 only), one photo of the studio or workshop (tools, supplies, work area should be seen), one of the outdoor booth display and three photos of the individual art pieces. Failure to provide photos with the application will result in automatic rejection.

**FEES:** The booth fee (10 X10 - \$125.00, 10 X 20 - \$250.00) and a \$25.00 non-refundable jury fee (separate check required) must be submitted along with the signed application. Artists are solely responsible for collecting, reporting and submitting payment to the Georgia Department of Revenue, Sales and Use Tax Division-sales tax is 6%. No refunds will be issued once acceptance notifications have been sent. Those applications not accepted will receive their photos and booth fee check in the mail. Jury checks will be deposited when the applications is processed, the booth check will be deposited after the jury process is complete (around Sept 25<sup>th</sup>). Post dating checks is prohibited.
